

Dear Congress,

## Renew MIECHV for five years without a state match.

The Maternal, Infant, and Early Childhood Home Visiting (MIECHV) program supports voluntary, evidence-based home visiting models in all 50 states as well as many territories and tribal communities. Home visiting breaks multi-generational cycles of poverty and puts families on the path to good health, educational success and economic stability.

Despite strong bipartisan support and decades of evidence that MIECHV-funded home visiting programs work, Congress allowed MIECHV to expire on September 30. One funding renewal proposal would undermine home visiting programs across the country by imposing a dollar-for-dollar state match.

Thousands of people – including governors, parents and home visitors – are calling on Congress to renew home visiting for five years without a state match, because:

**Children and families are counting on Congress to reauthorize MIECHV quickly, with stability and for the long-haul.** Two years of funding does not cover the two-and-a-half year – or longer – commitment that programs make to children and families. Short-term funding will prevent long-term planning, making it harder for programs to retain workers. And once the home visitor-family relationships at the heart of home visiting – the very relationships that make it so successful – are lost, the damage will be irreversible.

**States do not have the money on hand to make-up for Congress’ inaction,** which could force states to make tough decisions about the future of the program, including shutting down local programs. With nearly half of states facing budget shortfalls, requiring states to match funds dollar-for-dollar could also force states to divert or cut money from other crucial programs – negatively impacting the very health, economic and education outcomes members of Congress are trying to improve through home visiting.
